The competition will be held in accordance with current USEA and USEF rules.

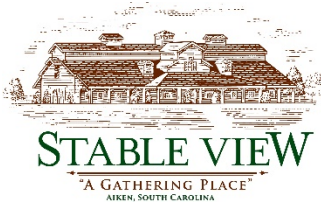
Valid negative Coggins within last 12 months required.

Awards:

Ribbons awarded 1st through 6th place.

The 2018 Eventing Academy Series will be from February through November. Year-end prizes will be awarded at the December 2018 Eventing Academy Competitor's Party. Competitors placing 1st through 6th in their class will be awarded points as follows: 1st place – 7 points, 2nd place – 5 points, 3rd place – 4 points, 4th place – 3 points, 5th place – 2 points, and 6th place – 1 point. Horse and Rider combination with the most accumulated points at each level will receive year-end prizes. In addition, the horse and rider combination who has won the most points overall will be presented a grand prize.
